

SUB.- GRANT OF PROVISIONAL RECOGNITION TO SCHOOL FROM  
CLASS I TO CLASS X (WITHOUT AID) W.E.F ACADEMIC SESSION 2005-  
2006.

Sir,

With reference to the application dated 26.2.2004 on the subject noted above, I am directed to convey that N.K. Bagrodia Public School, Dwarka is granted Provisional Recognition under rule 52 of Delhi School Education Rules 1973 from class 1 to class X (without aid) w.e.f. the academic session 2005-2006 subject to the fulfillment of the following terms and conditions:-

1. That the school shall abide by the provision of DSEA, 1973 and Rules framed there under as well as the instructions issued by Directorate of Education from time to time by the Department.
2. That the school shall admit the students without any discrimination of cast and creed as per norms of the department.
3. That the school shall appoint full time qualified and eligible staff as per the norms of the Department.
4. That a proper library shall be established and facilities for reading rooms shall also be made available for student as well as teachers. Books as per the ratio of 10 books per student may be provided and facilities of reading room shall also be provided immediately and more books worth Rs 5000/- be purchased by the start of next session and list of books furnished to the Education officer for verification. Adequate sports material shall be purchased and made available to the students immediately.
5. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules 1973 and payment will be made as per section 10(F) of Delhi School Education Act and Rules 1973 read with 126 of the rules to all the employees. The salary should be paid by crossed cheque.
6. That the school shall equip the science Lab as per the norms of the department and suitable facilities for practical work shall provided to the students.
7. More science goods worth Rs 5000/- shall be purchased during current year and list be furnished to the Education Officer for verification with in a year of the date of the recognition.


8. That enrolment in each section shall not exceed the number of the students calculated @ 10 sq ft per student for the available floor area of the class room and school shall provide adequate and sufficient accommodation as per the norms of the Dte. Of Education, Delhi in each class.
9. That the school shall dispense with the services of the unqualified and over-aged staff, if any immediately.
10. That the Govt. nominees on the managing committee to be constituted as per the approved Scheme of Management will be asked for immediately.
11. The Managing Committee of the school shall not enhance the fee during ensuing academic session without the prior approval of the Dte. Of Education.
12. The Managing Committee of the school shall regulate the functioning of the school strictly in accordance with the provisions of the Act and the Rules.
13. That all the facilities prescribed under Rule 50 and 51 of the DSER, 1973 shall be made available to the students.
14. That the arrangement of good drinking water shall be made available to all the students/teachers and the sanitary facilities shall also be provided to the students immediately.
15. Fresh health certificate may be obtained from the MCD within a month and be submitted to the EO concerned for verification.
16. The Managing Committee of the school shall create a reserve fund equivalent to the three months salary or one lakh + Rs. 80 per student which ever is less in a joint account in the name of the Dy. Director of Education (South-West-B) and the manager of the school in any scheduled bank within three months.
17. Proof to the effect that the staff has been appointed as per recruitment rules be provided to the Education Officer for his verification.
18. That a copy of the appointment letter issued to the staff be provided to the Education Officer for verification.
19. That the school shall not run any unrecognized classes or any other activities within the school premises and all the recognized classes shall be run at one place at the above said address only.
20. A sum of pay etc due to pay fixation of the Fifth Pay Commission Report 1996 remaining unpaid salary be paid immediately.
21. Provident fund register be maintained and cash book be completed and shown to the EO of the concerned zone for verification from time to time.
22. That the violation of any instruction/conditions/orders rules and regulations of the department shall lead to the withdrawal of recognition of the school and class XI shall not be opened without the prior approval of the Dte. Of Education.

23. that free-ship to the students belonging to the weaker sections as laid down under the orders issued by the Director of Education dated 27.4.2004 are strictly complied.
24. The school does not have the sanctioned plan passed by the local competent authority. Recognition has been granted to the school owing to the demand of the school in the area and as such this recognition is without prejudice to the claim of regularization of the school building or its demolition on account of the structure being unauthorized and in that event the Directorate may be intimated to make alternative arrangement for the students studying in the school.
25. That the school authority would submit Building Completion Certificate and water test report issued by the local competent authority by 30.4.2005 failing which the provisional recognition would be liable to be withdrawn.
26. That the provisional recognition would be effective from the academic session 2005-06. The Dte. Of Education does not recognize class VIII started by the school without getting recognition. The school would, therefore, take admission in class IX only in respect of students having passed class VIII from a recognized school.
27. That the report of the fulfillment of the conditions giving the extent to which each condition has been fulfilled shall be sent to the Education Officer every six months.


